“Understanding the Perspectives of Key Stakeholders toward Medicare’s Home Health Value-Based Purchasing (HHVBP) in the US”

HIGHLIGHTS:

Researchers found four major themes in their interviews including:

- ▶ Stakeholders, regardless of type or location, demonstrated significant differences in their feelings and understanding of the Home Health Value Based Purchased (HHVBP) program;
- ▶ Potential impacts and consequences for home health agencies and patients;
- ▶ Numerous different tools and approaches for home health agencies in the HHVBP model; and
- ▶ How HHVBP fits within the broader delivery of care and payment systems.

▲ RESULTS

Within the four major themes, opinions were relatively split amongst participants with concerns about the potential impacts for patients being a top cited worry. Stakeholders specifically cited the ability to care for high-risk patients and access to care as major concerns with the current implementation of HHVBP.

Agencies are responding to the nationwide HHVBP rollout using different strategies. Some of the strategies used included, town halls, adding clinical managers, new workflow plans for clinicians, providing OASIS scores and outcomes directly to clinicians, and more.

Given the workforce challenges and integration of concurrent payment and care models, stakeholders expressed concerns about being able to successfully navigate HHVBP. Stakeholders feel stretched with the post-COVID staffing shortages and the implementation of the Patient Drive Groupings Model (PDGM), and expressed confusion on how HHVBP would integrate with the rise in Medicare Advantage patients.

Impact for Home Health Care: As the HHVBP program enters its fourth year, understanding the attitudes and knowledge of stakeholders in home health care is vital to being able to successfully navigate the program. This research demonstrates that there are still critical knowledge gaps in understanding HHVBP and tools needed to successfully provide care within the model.

Members of the team were involved in a Centers for Medicare & Medicaid Services Technical Expert Panel on HHVBP. Findings from the TEP meeting in Fall 2023 informed performance measures included in the FY2025 Home Health Prospective Payment System Proposed Rule.

▲ OVERVIEW OF RESEARCH

Researchers interviewed key leaders in home health, home health agency staff, and clinicians on attitudes regarding the Home Health Value Based Purchasing program (HHVBP), both during those initially included in the nine state pilot and then the remaining 41 states.
